Franklin County Recorder—18 <sup>th</sup> floor	Once a document transferring a property has been executed, it must be recorded at this office to be valid.  You can also record your DD214 (free of charge) and advanced directives for end of life (\$40 fee), to ensure official copies of these are available to your loved ones. Franklin County Treasurer—17 <sup>th</sup> floor	This is the office where you can pay property taxes. You may also choose to set up Budget Payment, monthly tax payments which can provide a small interest-earned tax advantage. The office may be able to refer you to assistance if you are having trouble paying your property taxes. A surviving spouse may be able to transfer auto title(s) without going through Probate Court, using the affidavit in the link to the right.
